Mr. Thalman moved, seconded by Mr. Palmer, that the minutes of the July 18, 2017 meeting be approved as received. Motion carried.

MAYOR'S REPORT

Mayor Elliott reported on the recent flooding events that occurred in Wards 4, 5 and 6, and thanked Public Works Director Rusty Jebbia and all the city crews who have been working diligently in the clean up. He also thanked Councilor Scatterday, who not only suffered flooding herself, but also helped lead a community-wide effort. We are actively looking at existing Federal grants that we may qualify for as a result of the frequency and intensity of our flooding. Ms. Scatterday is working on updating phone numbers for assistance and volunteering and these will be available soon. Special trash pick-up will continue this week. Please leave items on front curb or alleyways. Mud should be piled along the front curb and will be picked up by the Operations Department.

Mayor Elliott announced that Wheeling was ranked 61st in the nation for top cities to start a small business, 1st out of five West Virginia cities.

Mayor Elliott announced that the National Night Out is this evening, 6-8 p.m. at Wheeling Park's Ice Rink. The Wheeling Police Department, the Wheeling Fire Department and the Ohio County Sheriff's Office will take part in this event. Also, he announced that the Debbie Green Memorial 5K is this weekend and the Heritage Music BluesFest will be held next weekend.

Mayor Elliott presented a proclamation to representatives of Relay for Life, proclaiming Friday, August 11, 2017 as Relay for Life Day in the City of Wheeling.

Mayor Elliott reported that Council will be voting by voice today as the touchscreen is still disabled.

Mayor Elliott indicated that there are two resolutions on tonight's agenda in regard to the Downtown Facade Improvement Grant. He said that four businesses have taken advantage of the grants thus far.

REMARKS FROM MEMBERS OF COUNCIL

Ms. Scatterday announced that Ward 4 Crime Watch will be held next Tuesday, August 8th at 7:00 p.m. at Temple Shalom. She reiterated Mayor Elliott's comments in regard to the recent flooding. She asked the public to remember that there is still help needed to assist those that were impacted, either physically or monetarily. She said that there is a Crisis Cleanup number that residents can call - 1-800-541-1854 if they need help. If you are willing to help, there is a location behind WesBanco Arena that is open daily between 8:30 a.m. and 2:00 p.m. where you can sign up to help.

Mr. Thalman thanked Ms. Scatterday and everyone involved in the clean up efforts. He announced that the Ward 1 meeting will be held next Thursday, August 11, 2017 at the Warwood Christian Church.

Mr. Wilson asked for a moment of silence in memory of the lives that were lost during the flood.

REPORT OF COMMITTEES

Mr. Thalman moved, seconded by Mr. Palmer, to dispense with the reading of the Finance Committee minutes of the July 18, 2017 meeting, and accept them as received. Motion carried. For the record, they are as follows:

FINANCE COMMITTEE REPORT - July 18, 2017

The Finance Committee of Wheeling City Council met on Tuesday, July 18, 2017 at 4:45 p.m. in City Council Chambers. Committee Members present: Chair Chad Thalman, Vice Chair Dave Palmer, Member Wendy Scatterday. Others present: Mayor Glenn Elliott, Councilors Ken Imer, Brian Wilson and Ty Thorngate; City Manager Robert Herron, Finance Director Seth McIntyre, City Clerk Janice Jones and the media.

The following matters were discussed:

Financial Statement - June 30, 2017

City Manager Robert Herron explained that this is the final budget analysis for this fiscal year. He reported that the General Fund Revenues for the year are \$33,789,000, which exceeds the budgeted estimated revenue. The expenditures were \$32,433,619. Mr. Herron said that the Budgeted Cash Carryover, after subtracting the encumbrances, is approximately \$992,000.00 and recommendations for the Cash Carryover will continue after this report. Mr. Palmer moved, seconded by Ms. Scatterday, to approve the Financial Statement for June 30, 2017. Motion carried.

General Fund Budget Revision No. 1

City Manager Herron commented that, in accordance with West Virginia Code, the unencumbered carry-over needs to be appropriated by City Council. As mentioned previously, the cash carryover is approximately \$992,000.00. Mr. Herron reviewed the Proposed General Fund Budget Revision No. 1, in the Operating Budget, both revenue and expenditures, for FY 2017-2018, He then reviewed the Sales Tax RCIP Budget and the recommendations for the cash carry-over (see attachments). The proposed appropriations for the cash carryover are as follows:

City Manager Herron also indicated that he is recommending a 2% or 2.5 % raise for city employees, not to be included in the carryover. This is estimated to be an annual cost of \$325,000.00. Following a question and answer period, Ms. Scatterday moved, seconded by Mr. Palmer, to forward this to Council. Motion carried.

There being no further business to come before the Committee, Mr. Palmer moved, seconded by Ms. Scatterday, to adjourn. Motion carried. Time: 5:12 p.m.

REPORT OF CITY MANAGER

City Manager Robert Herron commented that Item 9/1, regarding Privilege Tax, for For Profit Acute Care Hospitals, will require a public hearing which will be held at the August 15th City Council meeting and also Item 9/4, regarding Street Vendors, will also require a public hearing at the next Council meeting.

City Manager Robert Herron said that there was a website, operated by a company that was trying to sell water filters, that was very critical of our water treatment and our water supply. He asked Dave Nickerson., Water Superintendent, and Lori Siburt, chemist at the Water Treatment Plant, and Bob Smith from the WV Department of Health. They talked to Council about what we do from a water treatment perspective and how the City meets or exceeds all federal and state standards. Relevant to the critical website, it has since been removed. The Legal Department indicated that we could send a letter to the company telling them that they must register with the City before soliciting door to door.

Ms. Scatterday recused herself for voting for the Greater Wheeling Coalition for the Homeless as she serves on the Board. Mr. Palmer questioned the reduction of the Administrative Personnel Services line item to fund these increases. Mayor Elliott called for a vote on the amendment but noted his abstention on this particular amendment. Mr. Thalman, Ms. Scatterday and Mr. Wilson voted in favor of the amendment and Mr. Palmer voted no. There was not a majority of members of Council who were in favor of this amendment; therefore, the motion to amend was defeated.

A vote was then taken on the adoption of the Resolution. Motion carried. All in favor.

THOSE WISHING TO BE HEARD

Mr. Robert Baker, 109 Park View Lane, was present to discuss a road condition on Park View Lane that he believes is hazardous. Pictures of the situation were distributed via email. He invited Council to come out and view the area personally.

There being no further business, Mr. Thalman moved, seconded by Mr. Palmer, to
