Mr. Assaro expressed thanks to our city employees, specifically our Operations, Sanitation and Water departments who have been working to clear the snow.

Ms. Cain reminded of the Downtown Business Crime Watch Meeting being held at police headquarters on February 4 beginning at 5:30.

Mr. Sklavounakis asked Chief Jim Blazier from the Fire Department give a quick announcement regarding how to prevent frozen pipes and reminded residents to call the Fire Department if they need any assistance.

Mr. Thorngate noted the success of the 2026 State Hockey Championship that hosted six high school teams, five middle school teams, bringing in 2,500 fans at WesBanco Arena over the weekend.

Mr. Palmer remarked on the tabled ordinances regarding the bus stop move in Elm Grove, stating he plans to work with business leaders and OVRTA for the best solution.

FINANCE COMMITTEE REPORT

January 20th, 2026

The Finance Committee of Wheeling City Council met on the above date at 5:15 p.m. Committee **Members present**: Chair Palmer, Member Sklavounakis **Members Absent**: Vice Chair Thorngate **Others present**: Councilors Cain and Seidler, Mayor Magruder, City Manager Robert Herron, Finance Director Nathan Greene, Clerk Zalenski and members of the public and press.

Chair Palmer called the meeting to order at 5:15 pm the following was discussed:

December Financial Report

Mr. Herron presented the December Financial Report; he noted general fund is at \$964,00.00 and budget stabilization fund is up to \$5.53 million. Revenues after first six months of the fiscal year at 52.7% collected, ahead \$1.1 million to this time last year. Expenses at the half way point ate at 51.6% just 1.1% behind revenues. Overall healthy report so far into the fiscal year, January and February are large revenue months. Mr. Sklavounakis, seconded by Mr. Palmer moved to accept the December Financial Report as received. All in favor. Motion Carried.

General Fund Budget Revision #3

Mr. Herron and Director Greene explained the need for the budget revision. Funds are being allocated from one department to another to correct overspending. Mr. Sklavounakis, seconded by Mr. Palmer moved to send budget revision #3 to City Council for final approval. All in favor. Motion Carried.

Audit Scoring

Mr. Herron and Director Greene presented Audit Scoring for the 25-26 Fiscal Years. Request for Proposals for auditing services was sent to 7 State approved firms. Out of the seven three firms presented proposals and were graded using the State Auditor's worksheet, based on the scoring, Mr. Greene recommended the use of Perry & Associates. Mr. Sklavounakis, moved seconded by Mr. Palmer to accept the recommendation of Perry & Associates and send to City Council for final approval. All in favor. Motion Carried.

There being no further business to come before the Committee, Mr. Sklavounakis seconded by Mr. Palmer, moved to adjourn. Motion carried. Time: 5:21 pm.

REPORT OF CITY MANAGER

City Manager updated on Glenwood Road and Stackyard Road slips, noting FEMA is covering expenses due to it being a flood related event. Utility relocation will take a few weeks and will begin next week. Mr. Herron announced the city was awarded a Cybersecurity grant which will cover all \$230,000 in updates. Mr. Herron noticed council of the upcoming budget schedule. Mr. Herron noted congressional directed funding being approved and thanked Senator Capito and Representative Moore for their diligent work to secure the funding. Funding will be used for the Northern Parkway Improvements, Gateway Connector project and funding for Police Department and Wheeling Park Commission.
