The purpose of the public hearing is to present the FY 2025-2029 Five-Year Consolidated Plan for the city's housing and community development needs and the FY 2025 Annual Action Plan for the use of Community Development Block Grant (CDBG) funds in the amount of \$1,131,704.00 and for the use of HOME Investment Partnerships Program (HOME) funds in the amount of \$293,744.16. The city intends to submit these planning documents to HUD on or before Monday, July 14, 2025.

The Proposed FY 2025-2029 Five-Year Consolidated Plan and FY 2025 Annual Action Plan were prepared after conducting a public meeting on housing and community development needs, meetings with stakeholders, including housing providers, social and human service agencies, community and economic development organizations, faith-based organizations, meetings with the city's staff and officials, and the result of a community wide resident survey questionnaire.

If the city would undertake an activity that would result in the displacement of families or individuals, then the city would utilize its policy for minimizing such displacement. Furthermore, the city is responsible for replacing all low- and moderate-income housing units that may be demolished or converted as a result of CDBG or HOME funds.

All interested persons, groups, and organizations are encouraged to attend this public hearing and will be given the opportunity to present oral or written testimony concerning the proposed plans and use of

Federal funds under the FY 2025-2029 Five-Year Consolidated Plan and the FY 2025 Annual Action Plan.
