I wanted to give you a brief update of our status. We remain on schedule for the mid-march submissions as discussed at the December Planning Commission meeting.


The TIS study area has been approved by the WVDOH and the traffic counts are underway.

Although the WVDEP has not made a final determination, we remain confident based on our discussions with that office to date, that the proposed site grading pursuant to a development plan will be deemed an activity that is *exempt* from any quarry permitting. The project is expected to follow the normal storm water permitting process like any other similar development.

Finally, as to the additional geotech information requested, that report is also underway. I have attached the scope letter from David Hooper at Larson Design Group for your reference.

Larson Design Group (LDG) is pleased to present GC&P Development, LLC (GC&P) with this summary scope of services associated with the proposed development located in the vicinity of Bethany Pike (WV-88), Wheeling, Ohio County, West Virginia. We understand that there is a proposal for a split commercial and residential complex to be placed at this location. The purpose of this geotechnical report is to provide preliminary recommendations for the structures on the site, provide general site development guidance and to provide input regarding issues raised by the public.

#### PROJECT DESCRIPTION

The proposed development is in the planning stage and involves excavation from existing grade down to elevation 950 feet for the development of a building pad for mixed commercial and residential development. Current site plans are only at conceptual schematic level.

# Task 1. Review of Available Data

- Design and Construction Recommendations for foundations for the proposed structure types.
- Foundation bearing and settlement estimated for recommended foundation types.
- Potential impacts associated with coal mining at the project site.
- Other site development recommendations as possible based on existing design information.
