

WHEELING TRAFFIC COMMISSION – August 16, 2018

The Wheeling Traffic Commission met for its monthly business meeting on the above date in City Council Chambers with Chair Duvall presiding. The meeting was called to order at 2:00 p.m. *The prior meeting scheduled for August 9, 2018 was cancelled due to lack of quorum.*

APPROVAL OF MINUTES

Member King moved, seconded by Member Duffy, to approve the minutes of the July 12, 2018 meeting as presented. Motion carried.

NEW BUSINESS

Request by Arlene Nickerson, 42 Biltmore Ave, for handicapped parking space in front of residence. Ms. Nickerson was present on August 9, 2018 and spoke her need for request to Mr. Duvall and Mr. King. After an onsite inspection of all Commissioners Member King, seconded by Member Duffy to recommend the following traffic rule to Council:

TRAFFIC RULE 4684 TO ESTABLISH A HANDICAPPED PARKING ZONE ON THE WEST SIDE OF BILTMORE AVENUE DIRECTLY IN FRONT OF 42 BILTMORE AVENUE, IN THE CITY OF WHEELING, AND EXTENDING ON BILTMORE AVE FOR A DISTANCE OF 22 FEET

Request by Cynthia Young and neighbors for a three way stop at the intersection of Betty Street and McClurg Ave. After a discussion on August 9, 2018 and on-site inspection by commissioners Member Duffy, seconded by Member King to recommend the following traffic rule to Council:

TRAFFIC RULE 4685 AN ORDINANCE AMENDING THE TRAFFIC CONTROL MAP OF THE CITY OF WHEELING DESIGNATING THE INTERSECTION OF BETTY STREET AND MCCLURG AVENUE AS A THREE-WAY STOP INTERSECTION, STOPPING TRAFFIC MOVING IN ALL DIRECTIONS AT THE INTERSECTION OF BETTY STREET AND MCCLURG AVENUE

Request by Tim Birch to limit parking to one side of Jayson Street in Glenn Hollin from Glenn Hollin Rd to Faircrest Ave. Tim Birch spoke about this request and answered questions from neighbors: Cheryl Dougherty, 224 Faircrest. Concerns were addressed on August 9, 2018. After onsite evaluation from all commissioners Member Duffy, seconded by Member King to recommend the following traffic rule to Council:

TRAFFIC RULE 4686: TO ESTABLISH A NO PARKING ZONE ON THE WEST SIDE OF JAYSON DRIVE BEGINNING AT CORNER OF GLEN HOLLIN DRIVE AND JAYSON DRIVE, IN THE CITY OF WHEELING, AND EXTENDING NORTHERN DIRECTION ON JAYSON DRIVE TO THE INTERSECTION OF FAIRCREST DRIVE

Request by Tim Birch, to remove handicapped parking from 8th St, per request from Seeing Hands. The Handicapped space is located on a hill and difficult to use. A discussion ensued around where to move the space. There is concern about blocking vision on vehicles pulling out of parking lot if moved to Main St. Member King, seconded by Member Adams to remove the handicapped spot and table issue of new location until Seeing Hands can be contacted. The following traffic rule was recommended to Council:

TRAFFIC RULE 4687: TO ESTABLISH UNRESTRICTED PARKING ON THE NORTH SIDE OF 8TH STREET BEGINNING AT THE NORTHEAST CORNER OF MAIN STREET AND 8TH STREET, IN THE CITY OF WHEELING, AND EXTENDING IN AN EASTERLY DIRECTION ON 8TH STREET TO LANE B.

There being no further business to come before the Commission, Member Duffy, seconded by Member King, to adjourn. Motion carried. Time: 2:16 PM.
